
Adolescent Health Data

- According to data from HHS, 15% of adolescents aged 12-17 in Illinois have been diagnosed with a chronic health condition
- Over half of adolescents in the US who experienced a major depressive episode in the year before their report did not receive treatment
- Although 82% of women aged 15-19 at risk of unintended pregnancy were using a contraceptive method, only a little over half were using a highly effective method

2016-2017 National School-Based Health Care Census

- Conducted by national School-Based Health Alliance every 2 years
- 56/65 SBHCs reported for IL
- Unless otherwise indicated, data in this presentation is reflective of those that responded to the Census








Populations Served

- Average:
 - Visits per year: 1,967
 - Number of individual patients: 667
- 84% of users are enrolled in Medicaid or are uninsured*
- 62% of users are aged 12-20*






Student Population

- 66% of SBHCs are in schools where over 50% of students are eligible for free or reduced lunch
- 39% of SBHCs are in schools where over 90% of students are eligible for free or reduced lunch

Student Population Demographics






Accessibility


- See populations other than students at their location: 70%

- Open during the summer: 75%




Population Served: Beyond Students




Staff and Services

- Over half (64.3%) of SBHCs have an extended care team
- Almost all (95%) of SBHCs have both primary care and behavioral health staff and services




Physical Health Staff






Behavioral Health


- Average number of onsite BH service hours per week: 31
- Wide range of hours: 14% of centers offer less than 10 hours per week

BH Providers in SBHCs






Oral Health



- Average: 9.3 hours/week
- 47.8% of centers that provide oral health care only provide it 1-2 hours per week







Contraception Provision

- 77% of SBHCs offer some form of contraception, while 23% do not provide any form of contraception
- Survey looked at four categories:
 - Barrier methods
 - Oral contraceptives
 - Long-Acting Reversible Contraception (LARCs)
 - Emergency contraception
